TORM takes delivery of the sixth MR newbuilding from SUNGDONG

11 March 2016 - This week, TORM took delivery of TORM Troilus, the last out of six MR newbuildings from SUNGDONG Shipbuilding & Marine Engineering in South Korea. The six eco newbuildings in this series include; TORM Thor, TORM Timothy, TORM Thunder, TORM Titan, TORM Torino and TORM Troilus, all dwt 49,842 and IMO 2/3 vessels.

“With the delivery of TORM Troilus, we are pleased that all six MR newbuildings from Sungdong are now trading in our MR fleet,” says CEO Jacob Meldgaard.

Apart from the six MR vessels, TORM has four LR2 newbuildings on order from Guangzhou Shipyard International with delivery during next year and first half of 2018.
